### Introduction to classification units

We group all firms into classification units based on the products produced, the services provided, and the processes, technology, or materials used. The base premium rate reflects the cost of compensation and prevention in the classification unit.

This classification unit description provides an overview of the classification unit for general guidance only. Firms are classified based on this, our classification policies, Rate and Classification List, and other relevant classification unit descriptions. The items listed below are examples only; they are intended to be illustrative (not exhaustive). Every example may not apply to every firm in the classification unit.

**Description** This classification unit covers firms primarily engaged in operating a shake or shingle mill at a permanent location. These firms may load logs onto a conveyor; cut logs into rounds; split rounds into blocks; feed blocks through shake or shingle saw; grade, sort, bundle, stack; store finished shakes, shingles or ridge caps.

**Hazard rating assignment** Based on the nature and extent of the risks and hazards in this classification unit, firms in this classification unit are assigned a high hazard rating for the purpose of defining first aid-related requirements (i.e., the application of G3.16, First aid assessment, in the Occupational Health and Safety Regulation). This section of the Regulation specifies mandatory minimum levels of first aid, including what type of first aid kits, facilities, and equipment are required.
