# Hazard rating assignment

This section of the Regulation specifies mandatory minimum levels of first aid, including what type of first aid kits, facilities, and equipment are required.

### When to contact us

Firms in this classification unit may also occasionally engage in other business activities. However, if they have a significant presence in any of the following industries, it may make sense for them to be assigned to another classification unit.

- 1) installation, service or repair of asphalt roofs, low slope roofs, gravel roofs, or torch on roofs (see CU 721036); or
- 2) cleaning, power washing or restoration of roofs which does not require the worker to walk on the roof (see CU 764022).
