**General** information

Building framing activities done in connection with wood frame building construction includes residential concrete forming, placement of roof trusses, sheathing roofs and installation of windows and/or doors to get the building to lock-up.

Hazard rating assignment

Based on the nature and extent of the risks and hazards in this classification unit, firms in this classification unit are assigned a high hazard rating for the purpose of defining first aid-related requirements (i.e., the application of G3.16, First aid assessment, in the Occupational Health and Safety Regulation). This section of the Regulation specifies mandatory minimum levels of first aid, including what type of first aid kits, facilities, and equipment are required.

When to contact us

Firms in this classification unit may also occasionally engage in other business activities. However, if they have a significant presence in any of the following industries, it may make sense for them to be assigned to another classification unit.

- 1) structural concrete forming (see CU 721052);
- 2) finishing carpentry activities such as installing cabinets manufactured by others, construction of built-in furniture or cabinets onsite, or installing such items as door trims or mouldings (see CU 721021);
- 3) concrete placing, finishing, surfacing, or repair (see CU 721010);
- 4) concrete pumping (see CU 721011);
- 5) drywall installation (see CU 721018); or
- 6) installation of doors or windows independent from framing services (see CU 721021 and CU 721059).
