

2024 POP Compensation Table

How to read the table

To determine your average weekly wage rate, we start with your purchased monthly amount of coverage. We then deduct probable taxes to determine the calculated net earnings. The compensable weekly amount is then 90% of the calculated net earnings. The table below shows this and reads from left to right.
