# Accessing disclosures online

#### 1. What are disclosures?

Disclosures are documents or records relating to a worker's claim with WorkSafeBC — from medical history to treatment plans and personal information — that we provide to health care providers to help support their treatment of injured workers.

#### 2. Who can access disclosures online?

Only health care providers who use our **Provider Portal** can access disclosures online. If you are a provider who does not use our Provider Portal, you will receive disclosures through secure email.

### 3. Can I search and sort claim files within this application?

Yes, each column has a filter that allows you to sort disclosures by claim number, date, program location, name of worker, and more.

### 4. How long will disclosure packages be available online?

They will be available online, as PDFs, for 60 days. After that, if you haven't yet downloaded them, contact Provider Referrals at 604.231.8887 or 1.866.481.8887.

### How to access disclosures

- 1. Go to the Provider Portal at myworksafebc.com and enter your BCeID and password to log in.
- 2. Once you reach the home screen, select "Downloads."

### How to manage your downloaded disclosures

Within the "Downloads" tab, the default view shows you all the new downloads available. Once you've downloaded a disclosure and you wish to file the download, click the "Completed" checkbox, and that download will be moved to the completed list. You can view the completed list at any time by clicking the "Completed" filter on the left side.

To return to your new downloads list, click the "New Downloads" filter on the left side.
