## INTRODUCTION

About 800 farm and ranch workers are injured every year in work-related accidents in B.C. Workers fall from ladders, are stepped on by animals, struck by falling objects, and mangled by machinery. On average, 4 agricultural workers die from their injuries every year.

In 1993, farms and ranches came under special Workers' Compensation Board (WCB) health and safety regulations — *Regulations for Occupational Health and Safety in Agriculture* — to protect workers from injury and disease. These cover general requirements on matters such as health and safety programs and the condition of the workplace, as well as hazards specific to agriculture.

In addition, some of the general health and safety regulations that apply to other industries in B.C. also apply to agriculture. These are in the Occupational Health and Safety Regulation. They include Workplace Hazardous Materials Information System (WHMIS) requirements in Part 5 and Occupational First Aid requirements in Part 33.

In 1999, amendments to the *Workers Compensation Act* came into effect. These apply to all sectors, including agriculture. They address matters such as workplace responsibilities, worker participation in health and safety, and due diligence.

The following checklist covers some common agricultural safety concerns and WCB regulations that apply to farms and ranches. If all your answers on the checklist are “yes”, you probably have a safe farm or ranch, but it does not necessarily mean your farm or ranch is in compliance with all the regulations.



## HEALTH AND SAFETY REGULATIONS

## HAZARDOUS SUBSTANCES

Are substances that might harm workers marked with signs or symbols?

  

Have workers been told what to do if a harmful substance spills?

Does everyone working around anhydrous ammonia wear hand and eye protection?

## PESTICIDES

Are pesticides for use in the fields registered in Canada and labelled according to the *Pest Control Products Act* (Canada)?

Are all workers who mix, load, or apply moderately or very toxic pesticides *over the age of 16*?

  

Are all workers who clean or repair the equipment used for pesticides *over the age of 16*?

  

Do these workers hold applicator certificates from the B.C. Ministry of Environment, Lands and Parks?

  

Do they wear the right protective clothing and equipment?

  

Are washing facilities available for workers who mix, load, and apply pesticides?

  

Before any fumigants or other moderately or very toxic pesticides are applied, are warning signs posted where workers enter the area?

Has the employer taken precautions to prevent the drift or spread of pesticides?

## CONFINED SPACES

- Mesh or nip-points of all power-driven gears, belts, chains, sheaves, pulleys, sprockets, and idlers?
- All revolving shafts including protruding bolts, keys, or set screws?

If a farm tractor was manufactured after Jan. 1, 1985, does it have roll-over protection?

Do all tractors with ROPS have seatbelts?



Are the seatbelts used whenever the tractor is moving or equipment is unstable?
