

WorkSafeBC Fee Schedule for Orthotics

RULES APPLICABLE TO ELIGIBILITY TO INVOICE FEE CODE AND FEE CODE INCLUDED ITEMS

Providers are required to complete and submit the [Request for Authorization for Orthotics Services Form 83D20](#) using the appropriate item code(s) to obtain pre-approval prior to dispensing the service.

1. The Payment Schedule includes the services of Certified Orthotists who are certified members in good standing with Orthotics Prosthetics Canada, Pedorthists who are registered members in good standing with the College of Pedorthics of Canada, and Podiatrists accredited by the Canadian Podiatric Medical Association.
2. Once preapproved, the orthotic services are to be invoiced in full.
3. The Certified Orthotist, Pedorthist or Podiatrist will invoice WorkSafeBC only for services provided under this Payment Schedule, and will not invoice the Medical Services Plan (MSP) nor the injured worker.
4. The fee for orthotic treatments (orthoses) includes the follow-up period, normally considered to be 90 days.
5. The orthosis must be provided to the Injured Worker prior to invoicing WorkSafeBC.

Certified Orthotists can provide and invoice any orthoses to injured workers using the following fee codes only:

19211	Custom Orthotics – Spine (other than Cervical)
19212	Custom Orthotics – Upper Extremity
19213	Custom Orthotics – Pelvis and Hip

Certified Pedorthists can provide and invoice only orthoses below the ankle level for injured workers using the following fee codes only.

Invoices for the provision of any orthoses at or above the ankle e.g. ankle/foot orthosis (AFO's) and knee braces will not be reimbursed.

Podiatrists can provide and invoice orthoses below the knee for injured workers using the following fee codes only.

Invoices for the provision of any orthoses at or above the knee level e.g. knee braces will not be reimbursed.
