Link changes for OHS Provisions of the *Workers Compensation Act 2019*

On April 6, 2020, global changes to the *Workers Compensation Act* will take effect. These amendments are not substantive in content but will require WorkSafeBC, associations, and employers to update materials that reference the Act.

The changes include a reorganization of the Act's components, some new wording in various sections, and deletion of provisions that have been repealed or are no longer needed. The occupational health and safety provisions, Part 3 of the *Workers Compensation Act 1996*, will be Part 2 in the *Workers Compensation Act 2019*, when it takes effect on April 6, 2020.

The following table provides links to the health and safety provisions of the *Workers Compensation Act* as they will be on WorkSafeBC's Searchable OHS Regulation & related materials webpage when the revisions take effect. Section numbers from the 1996 Act are given, along with their corresponding division numbers, section numbers, and section names in the 2019 Act.
